Vendor will provide everything necessary for the set-up and function of space within the 10x10 dimension. The Copiague Chamber of Commerce, Long Island Family Fun Festival, Inc. and Nightingale & Nightingale, Inc. cannot be held responsible if vendor cannot set up space within the allocated dimension. Vendor will be responsible for setting up and removing exhibit and garbage each day. If the space inhabited on Saturday is not left in the condition in which it was found, vendor will not be permitted to return on Sunday and there will be no refund issued.

Any vendor arriving to set up past 10 am will not be permitted to drive into the festival area and will therefore not be allowed to drive to their pre-assigned space. Vendor will then be responsible to transport items by foot and there will be no refund for lost time. Vendor understands that all vendors are independent agents. Vendor will comply with New York State Law that requires sales tax to be collected. Vendors who participate in this year's LI Family Festival will receive priority status to join the 2023 LI Family Festival regardless of event location should the vendor want to participate. Vendor agrees not to compete against or disclose proprietary information.

Vendor shall and will hold harmless the Copiague Chamber of Commerce, LI Family Fun Festival, Inc. and Nightingale & Nightingale, Inc. and its members from and against any and all claims, liabilities, demands, expenses, fees, penalties, suits, proceedings, actions and causes of action of any and every kind and nature arising from or out of, or in any connected way with vendor use, occupancy or activities in or related to the LI Family Festival. **Vendors will be personally liable to other participating vendors and members of the public for their own acts and are responsible for obtaining their own insurance.**

Vendor understands that neither the Copiague Chamber of Commerce, LI Family Fun Festival, Inc. and Nightingale & Nightingale, Inc. nor its members will be responsible for loss and/or damage to vendor's personal property caused by any reason and will not assert any such claim against them. The Copiague Chamber of Commerce, LI Family Fun Festival, Inc. and Nightingale & Nightingale, Inc. reserve the right to cancel the entire event, or any part or day of the event should an emergency arise, should the pandemic or other disaster require the closure, due to an Act of God or if there is inclement weather. **There will no refunds granted should a cancellation for any reason of any part, any day or the whole event take place.**

# **WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT**

1. In consideration for receiving permission to participate in the event, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, Town of Babylon, Copiague Chamber of Commerce, Nightingale & Nightingale, Inc., LI Family Fun Festival, Inc., their officers, agents, servants, pets, or employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or any participants at this event, or any of the property belonging to me or any participants, or any action resulting upon my instruction or my coordination of activities for this event. WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted.
2. I am fully aware of the risks involved and hazards connected with this activity, including but not limited to travel risks and/or possible event accidents. I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me or any participants, or any loss or damage of property owned by me or participants, as a result of being engaged in such activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.
3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation and coordination of said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.
4. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of New York.
5. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
6. The Long Island Family Festival has put preventive measures in place due to the spread of COVID-19. However, attending an event could increase your risk of contracting the coronavirus. By participating in this event, you voluntarily assume all risk and agree that you will not hold the liable for any resulting illness, injury or death. If such injury or death results from the inherent risks of contracting COVID-19, you are assuming this risk by agreeing to participate in this event.

## COVID-19 Vendor Agreement and Acknowledgement

Due to the ongoing threat of COVID-19, all Long Island Family Festival Vendors will be required to agree to the following policies. Please sign below where indicated.

### LONG ISLAND FAMILY FESTIVAL COVID-19 VENDOR POLICIES

*By signing this document, you are agreeing to the items listed below:* Vendors who violate COVID-19 policies will forfeit their vendor fee for noncompliance of the Festival COVID guidelines and will not be allowed to apply to be a vendor at the 2023 Long Island Family Festival until after the regular application period has closed if space allows.

- Vendor understands that the festival's location in Tanner Park is a public park. It is possible that people visiting the festival have been exposed to and/or have been diagnosed with one or more communicable diseases including but not limited to COVID-19 or other diseases or maladies. It is impossible to eliminate the risk that vendor, or other occupants, might be exposed to and/or become infected through presence in the festival or participation in festival related activities. The undersigned understands the risk and expressly assumes responsibility for said risk.
- Vendor will require all employees/volunteers within their vendor booth to follow Local Town, State and National COVID guidelines and mandates.
- Vendor will make hand sanitizer available when possible, in a visible location for festival attendee use at their booths.
- Vendor will make every effort to provide contactless payment options for festival attendees when possible.
- Vendor will require all booth employees/volunteers to monitor their health and will not allow an employee or volunteer to work at their booth if they are exhibiting any COVID-19 symptoms to include, but not limited to: fever, shortness of breath, active cough, runny nose, sore throat, or loss of taste or smell.
- Vendor agrees to report any sudden onset of COVID-19 symptoms in their employees/volunteers to include fever, shortness of breath, active cough, runny nose, sore throat, or loss of taste or smell during festival hours to a festival representative for further guidance. Vendors who experience COVID-19 symptoms during festival hours will be asked to vacate the festival premises.
- Vendor agrees that vendor employees/volunteers will not attend the LI Family Festival if they or anyone in their households have tested positive or have come into direct contact as defined by CDC for COVID-19 during the period of September 1, 2022 through September 19, 2022 (or October 3 if rain date is used).
- Vendor agrees to report all incidents of an employee or volunteer testing positive for COVID-19 within 14 days after the LI Family Festival takes place. Please e-mail [alyssa@nightingalepr.com](mailto:alyssa@nightingalepr.com) or phone 631-367-8599.
- Vendor agrees to promote and enforce social distancing for customers in line or visitors at their booth.
- Vendor agrees to abide by all applicable NYS, Suffolk County, Town of Babylon and LI Family Festival guidelines while at the Long Island Family Festival and to clean frequently touched surfaces throughout the duration of the festival.

### COVID-19 VENDOR RISK ACKNOWLEDGEMENT

Vendor acknowledges that exposure to COVID-19 is an inherent risk in any public location where people are present; the Long Island Family Festival cannot guarantee you will not be exposed during your visit. The CDC advises that older adults and people of any age who have serious underlying medical conditions may be at higher risk for severe illness from COVID-19. Vendors and attendees should evaluate their own risk in determining whether to attend.
